

Business

Jedi Masters do not earn a high salary for their work; the average salary according to Glassdoor is \$57,425 per year. The Jedi Order provides a living wage but it's not enough to support a major gift to the institution. However, Luke has other assets, which is unusual for a Jedi. Please see below.

Stock

Luke inherited the deceased Jedi Knight Mace Windu's stock in Lightsaber Inc. As of June 14, 2018, Luke holds 5,982 shares, which have a value of \$145.68 per share as of January 23, 2019. This makes the value of his shares \$871,457.

Luke also inherited half of Master Yoda's shares of Frank Oz & Sons Co. The other half went to his sister, Princess Leia. He owns 178,473 shares as of September 9, 2018 that are valued at \$36.98 a share as of January 23, 2019 making his holdings worth \$6,599,951.

Family

Luke is the son of Padmé Amidala and Anakin Skywalker. His mother was the Princess of Theed and later Queen of Naboo. After her reign (Queens in Naboo are democratically elected), she served as a member of the Galactic Senate. Her parents were very well off in Naboo, owning several businesses. While some of those businesses were harmed during the Clone Wars, Luke and his sister likely inherited some wealth as Padmé only had one sister.

Luke's father, Anakin Skywalker (aka Darth Vader), also possibly passed along considerable wealth to his two children after his death. As the number two leader in the Galactic Empire, he had considerable assets. It is difficult to know, however, how much of that was could be given to his children when the Empire fell. Some of the funds may have been used as restitution for the over twenty-year destruction that the Empire caused. However, if any assets were remaining, they would go to Luke and his sister Leia as they were Anakin's only living relatives. Anakin's paternity was unknown, and his mother has passed away.

Luke was raised by his step-uncle, Owen Lars, and Owen's wife Beru, on the planet of Tatooine. Owen and Beru were killed by stormtroopers and had no children of their own. Their moisture farm was successful, and Luke inherited the land, but the farm was destroyed by the stormtroopers who killed them.

Luke has one sister, Leia Organa. Leia is married to Han Solo, a pilot and friend of Luke's. Luke and Leia have one son, Ben Solo, aka Kylo Ren. Luke was instrumental in raising Ben and may have helped pay for his education at the Jedi Academy. However, Ben and Luke have a contentious relationship ever since Ben turned to the dark side. This could free up any resources Luke was using for Ben.

It is possible that Luke has a child. Many in the galaxy believe that Rey, a young adult with unknown origins, who shows great promise as a potential Jedi Knight, could be his daughter. It is possible that he is secretly supporting her education to become a Jedi. This rumor cannot be confirmed.

Property

As previously mentioned, Luke owns his uncle's moisture farm on Tatooine. The value of the land is about \$875,000 according to Zillow. A purchase price or date is unknown as Tatooine does not keep property records.

Luke is a co-owner of his grandparents' home on Naboo, although he has stated that he rarely visits, and it is primarily occupied by his aunt. The other co-owners are Leia and Luke's aunt, Sola Naberrie. Luke's grandparents purchased the home 83 years ago for \$1.2 million and it has a current Zillow estimate of \$4.3 million.

Luke rents a small apartment on the capital planet of Coruscant, near the Galactic Senate. Zillow estimates that the rent for the apartment is \$1,450 per month.

Other Indications of Wealth

Luke possesses a personal collection of historic lightsabers, although he is very reluctant to talk about them in public. It is believed, according to Jedi Fan magazine, that he is searching for lightsabers that once belonged to famous Jedi Masters and Jedi Knights. Rumor states that he owns the lightsabers of Yoda, Mace Windo, Qui-Gon Jinn, and Plo Koon. A recent article states that he is still hunting for the lightsaber of Obi-Wan Kenobi, his old master. The value of these lightsabers is extremely high, although they do not come on the market frequently. A lightsaber believed to belong to Kit Fisto recently was sold, at auction, for \$5.3 million. The buyer was anonymous and could have been Luke. A lightsaber for a better-known Jedi, such as Kenobi, would be much higher.

As the one of the last living Jedi, it is possible that he inherited other assets from deceased Jedi. Jedi are not required to pay taxes or disclose their wealth, so their assets are generally unknown. Before the fall of the Jedi, they had an extensive archive, considerable property holdings, and an extremely valuable art collection. It is possible that Anakin Skywalker aka Darth Vader seized some of these assets when he took control. However, it seems likely that some of them would have been returned to the Jedi Order after the fall of the Empire.

Analysis/Conclusions

While most Jedi do not possess great wealth, Luke is likely an exception. As one of the last living Jedi at the time, he received stock holdings for Master Yoda and Mace Windu. He also has sole ownership of a moisture farm in Tatooine and is part-owner of a large estate on Naboo. He also may have inherited assets from his parents. Jedi are private about their wealth, so the monastic lifestyle Luke leads may be in contradiction to the wealth he holds. He likely has the capacity to make a major gift to our campaign.

Foundations and Funds

Luke is the sole director of the Force for Good Foundation. As of the last available 990 in 2016, the foundation had assets of \$38,539 and paid grants of \$7,830. Most of the grants given have been in the three or four figure range.

Gifts between 2013 and 2016 over \$5,000:

- \$5,000 to the Jedi Academy in 2016
- \$5,000 to the Jedi Academy in 2015
- \$5,000 to the Jedi Academy in 2014

Luke is also the President of the Skywalker Ranch Foundation. The only other director is his sister Leia Organa who serves as the Vice President. As of 2017, the foundation had assets of \$5,203,453 and gave grants of \$75,000. All the foundation's grants are five, six, or seven figures.

Gifts of Note

Luke personally gives to organizations where he feels a connection, including planets where he lived, organizations supporting Rebel veterans, the Ewok causes, and Jedi organizations. Luke's gifts range in size from \$200 to \$10 million.

Luke's largest gift was \$10,000,000 to the Jedi Academy, where he has been a board member for twelve years. The gift named the training facility the "Anakin Skywalker Memorial Training Facility" in 2010. He also has a personal interest in training new Jedi, so that the ancient order to which he belongs does not cease to exist. Please refer to the Great Jedi Purge where most of the Jedi order was wiped out by Darth Vader and his associates. Also, since Luke's nephew, Ben, was converted to the Dark Side he has a greater interest in supporting the education of new Jedi apprentices.

Personal gifts from Luke of \$10,000 or more since 2013:

- \$100,000-\$250,000 campaign gift to the Ewok Arts Center in 2015 (likely a \$500,000 pledge)
- \$100,000-\$250,000 campaign gift to the Ewok Arts Center in 2014 (likely a \$500,000 pledge)
- \$100,000-\$250,000 campaign gift to the Ewok Arts Center in 2013 (likely a \$500,000 pledge)
- \$10,000 -\$25,000 annual gift to the Ewok Arts Center in 2015
- \$10,000 \$25,000 annual gift to the Ewok Arts Center in 2014

Luke also gives political gifts, primarily to Friends of Senator Organa and the Organa Solo Campaign Fund. Leia Organa is his sister, so this is a logical area of support. Gifts have ranged in size from \$200 to \$5,000 to Leia's campaigns and PACs.

Additional Information

A former coworker, who worked for the Droid Rehabilitation League, mentioned that she believed that Luke was a major supporter. There was no indication that this is the case in our databases, but we know that they do not show all gifts. This support would not be surprising given Luke's friendships with the droids C-3PO and R2D2.

Analysis / Conclusions

Luke Skywalker is a major philanthropist in the Rebellion-controlled territories. He has given to a wide range of organizations in the political, human rights, health, arts, economic development, and education fields. He gives personal gifts as well as gifts through his two foundations. The largest support, both personally and through his foundations, has been to the Jedi Academy where he is a teacher and is training young Jedi. He has a personal interest in the cause, since he is training the next generation of his ancient order.

His giving patterns indicate that he may have an interest in our campaign to save transform the moon of Endor. He has donated to other economic development organizations, although the largest gift was \$5,000. However, he has given extensively to and is on the board of the Ewok Arts Center, showing his interest in Endor and the Ewok population. The Center has received the most gifts from him --15 since 2011 -- with total giving of around \$650,000. He may feel responsible about leading the Galactic Empire to the moon and being a part of the battle that ravaged the moon and the native Ewok population.

It is known that Luke maintains a friendship with Wicket W. Warrick, who is on the board of our campaign. They gave several interviews to Alliance Daily newspaper after the Battle of Endor and subsequent press releases show that they have maintained the relationship. We should ask Wicket if he is willing to approach Luke to gauge his interest.
